

BT Tower prize draw – terms and conditions

1. *Eligibility*

The prize draw is open to any UK resident BT shareholder or EasyShare participant (EasyShare is provided by Equiniti Financial Services Limited), aged 18 or over who has signed-up as an e-shareholder **by 31 July 2019**. This means that you must **both** have your dividend paid directly to your nominated bank or building society **and** have signed up for e-communication.

2. Anyone materially connected to the administration of this Prize Draw incentive will be excluded from participating.
